DEPARTMENT REPORTS

MISSIONS

In this last year, our church has supported the work of 24 field workers in 12 countries, 7 churches, and 8 Community Development Project Partners. This is an incredible number, made possible by the generosity of our church. We have supported two church building projects — in Japan and Romania — which has enabled both congregations to expand their evangelism and outreach efforts.

As a church we also support 3 ministries reaching persecuted Christians across the globe, which is challenging and dangerous work. Please continue to keep those field workers in your prayers.

Our crisis response has continued with funds sent to relocate refugees from Afghanistan and Ukraine. We have also supported the work of Allison and Narel Atkinson in Sri Lanka and their response to the economic crisis. This support will continue into the new financial year as we work with the Atkinson family.

Finally, the work the Pitjantjatjar Bible translation continues to progress well, and we look forward to seeing the finished product, which will bless our Indigenous Australian communities.

Thank you once again for your generosity church. Together, we continue to reach the world with the good news of the Gospel.

WORSHIP & CREATIVE MINISTRIES

This year has been an amazing and fruitful year for the Creative Ministries of Faith Church!

The whole team is thriving as we multiply, in numbers and in skill, with many new faces in our production and worship teams.

As the members of our Creative Teams seek the Lord individually and corporately, we are on the journey to develop a strong and unique sound for our house. We are seeing the emersion of songs written and crafted by our own songwriters and are excited for the future in this area.

Our Campus Creative Team Leaders, along with the rest of our Creative Core Team are doing an excellent job, leading with strength and stewarding the vision in their campuses and departments.

The quality of our livestream has continued to improve as we have trained more volunteers and upgraded some equipment. We are pleased to see a steady increase in reach on our online platforms and are proud to be sharing the quality of our worship and production teams with a wider audience.

Our team is sowing into our church with the design and installation of our Waverley Campus and heavy involvement in the plans for our Casey build.

We are excited for what the next 12 months holds for Creative Ministries and are honoured to serve our church.

DANDENONG PASTORAL CARE

We have had a strong year of pastoral care. We are still needed and welcomed to minister at ESTIA nursing home in Dandenong twice a month and have been able to respond to many after-hours calls from both, the nursing home and the hospitals. This has given us the opportunity to minister to many sick and dying. We've been able to make contact with many new people attending Faith, and numbers have decided to call Faith home. Pastoral care continues to those who call Faith home and we've also been able to bring pastoral care to people watching online. We look forward to what the Lord has in store for the year ahead.

CONNECT GROUPS & NEXT STEPS

I am so grateful to our Connect Group leaders, for their commitment to care for and minister to the people of our church. Many of these same leaders also serve in Next Steps, where we've seen a consistently steady stream of new people, those who have questions about faith and Christianity, and those who have committed their lives to Christ. I'm very pleased that Connect Groups have been an effective connection point for these new people.

As we've returned to in-person corporate gatherings, our connect groups have seen the benefit of a hybrid online/in-person model (always with a view towards in-person) and it's continued to be a way for many people to connect, who otherwise may not.

One highlight of this past year was a training session with Ps Glenise Dedrick from Chaplaincy Australia, who taught on Boundaries in Pastoral Ministry, and Effective Communication in your small group leadership. It was especially insightful given the extraordinary context of Covid and how it's affected people.

Another highlight was honouring Tim & Jean Retallack at Dandenong for their 38 years (and continuing) of Connect Group leadership. Well done!

We're looking ahead to more new groups starting, more leaders being trained up, and existing groups being strengthened in all that they do.

FAITH ONLINE

The emphasis on our online presence has taken on new meaning with the appointment of our first Online Pastor, Ps Nathan McMillan, in June of 2022. Throughout Covid restrictions we have been able to reach thousands of people around the globe through our steaming and other content. As things have reopened there are still many who solely connect with our church through online platforms.

As we continue to hear stories of God moving through these mediums of communication, the stronger our conviction to take the message of the Gospel to where people are, as there are so many people searching for answers on the internet. This new expression of FaithCC opens up new and exciting opportunity for discipleship and outreach.

FAITH KIDS

In June 2022, we saw a change in leadership as we welcomed Ps Angelina Kyriakou as our new Faith Kids Pastor. Since then, Faith Kids have committed to opening all three rooms at Dandenong for the Sunday morning services including the Nursery, Early Childhood, and Primary rooms. We have seen a significant return in nursery and primary aged kids which is largely reflective of our age-appropriate environments.

The vision at Faith Kids is to develop and build our leadership team through practical training and spiritual discipleship. We also seek to create a culture of connectivity and friendship amongst our kids and their families. This includes re-opening the Dandenong Community Café for our parents and providing outdoor activities for our kids after church services.

In summary, our vision at Faith Kids is to connect kids to God and with each other. Building a strong leadership team will help facilitate this.

YOUNG FAMILIES

I'm pleased to report that the Young Families in our church navigated the Covid season with strength and resilience, and as church came back to in-person services, we've seen our families returning and participating well.

The Young Families department has always worked closely with Faith Kids, and together in this last year we've had many catchups and connection points - opportunities for families to meet our pastors and leaders, for kids to meet other kids and have loads of fun, and to see families connecting into the life of our church in meaningful ways.

As we look ahead, we're currently seeing a new baby boom, and a lot more families with toddlers. Consequently, we've commenced a new Connect Group (Dandenong) for this demographic, with a view to expanding further.

I'm especially grateful to our Young Families connect group leaders, and all those involved in ministering to families across each of our campuses.

ONE YOUTH

One Youth has been absolutely pumping the last 12 months and we have seen so many young people come through our doors, get connected and planted into family. Our vision for 2022 has been "Building family one teenager at a time," and we have truly seen this become a reality.

After two years of restrictions, we were able to gather for the first time with all our young people across all campuses in one place. It was incredible to see our young people praise and worship and be in community together.

I can say without a shadow of a doubt that God is doing something supernatural in our youth ministry and young people are being healed, set free, and filled with His Spirit. I would like to thank every single youth leader because without them we wouldn't be able to take ground like we did this year. I am expectant for what God is going to do next year - this is just the beginning of a move of God.

YOUNG ADULTS

The last 12 months have been both challenging, through Covid lockdowns, but fruitful as we saw young adults navigating the reopening of workplaces, on campus study, and in person events.

Currently 494 young adults (aged 18-30) call our church home, with 53% having engaged in serving, connect groups, or YA events within the 21/22 financial year. Considering the challenges of this season, it is encouraging to see this level of engagement. With the transition of leadership to Ps Ramon and Bronte Raux from Ps Nathan and Linita McMillan, there is a new excitement for what God is going to do in our young adults community, among uni students, and beyond.

FAITH UNI

It has been a blessed 12 months as Faith Uni has returned on campus and been reaching out to University students once again as borders have reopened and students have been able to travel from overseas and interstate.

Over 2 Orientation Week Festival outreaches at Monash University Clayton, Faith Uni has reached out to over 200 students and connected with over 60 students who have expressed interest to visit our Church.

Our monthly outreach events on campus and connect groups over the last 6 months have been especially fruitful, where we have seen over 40 students from 9 countries including Zimbabwe, Malaysia, Iran, and Indonesia, either attend an event on campus or visit and get planted at Faith. We have discipled new student leaders while rebuilding a new team this year.

Over the next 12 months we are praying and believing for continued momentum and growth.

DANDENONG SENIORS

During the COVID period of 2020/2021, much of which was spent in lockdown, I had the privilege, along with other pastors, of phoning people, mainly over 50 years of age, and chatting about their family and needs, and praying for them. Different ones had different needs – health, financial, etc., but God ministered, as we prayed together.

Vera and John Lamb, have faithfully gathered the seniors together to have lunch and fellowship, every few months over many years. This wasn't possible during lockdown, but Vera organised a break-up lunch in November 2021. Sadly, John's health declined until he passed away on July 7th this year. We thank God for his faithful service, and wonderful life! Vera, will continue to bless us, by serving with us, in this ministry.

This year, we planned to have 'Lunch With Friends,' for seniors in the Community Café, and we've had two in May and July, with our next one in late September, and a break-up lunch in November. These events have been enjoyed by 30-40 Dandenong seniors — great times of getting together after two years apart, building new friendships, and sharing lunch together. If you're around 60 years +, please join us for 'Lunch with Friends' every two months! You'll meet some new friends and be blessed!

WE CARE COMMUNITY SERVICES

We Care has had a great 12 months! A season of fruitfulness and such expansion. Playgroups continues to go from strength to strength, running twice a week and seeing numbers of 60 people attending a session.

Our food relief program persists to be a magnification of the vision of We Care's heart. With demand of material aid support continually on the rise, we have forged new partnerships with Fare Share's food rescue program, food filled youth-based food rescue program, and a local Aldi, all donating varied several kgs of necessities to support our local community of approximately 1700 households requiring tangible support each month.

Our new cool room/freezer was installed by a grant opportunity which has changed the way we are able to operate and cater to this growth. We have strengthened relationship with long term partnerships of Woolworths, Foodbank, and the local council at the City of Greater Dandenong. Our association with Foodbank has been a highlight of the past 12 months, they now refer to us as a "key charity partner", as We Care is often hosting regular Foodbank pop up markets distributing 4500kgs of fresh fruit and vegetables directly to 300 vulnerable families bi-monthly working with well-known corporate sponsors and their staff from Ausnet and Peter's. This is a great way for We Care to offer extra physical support to people who are unable to provide enough food for their families along with sharing our heart, vision, phenomenal community café and impact with corporate businesses.

Overall, We Care has had a healthy season with ample growth across all areas. We are blessed and cannot wait to see what God has in store over the next 12 months.

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF FAITH CHRISTIAN CHURCH INC

Report on the Financial Report

Opinion

We have audited the accompanying financial report, being a special purpose financial report, of Faith Christian Church Inc (the association), which comprises the statement of financial position as at 30 June 2022, the statement of profit or loss and comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, notes comprising a summary of significant accounting policies and other explanatory information, and the responsible persons' declaration.

In our opinion the financial report of Faith Christian Church Inc has been prepared in accordance with Division 60 of the *Australian Charities and Not-for-profits Commission Act 2012*, including:

- a. giving a true and fair view of the association's financial position as at 30 June 2022 and of its performance for the year ended on that date; and
- b. complying with Australian Accounting Standards to the extent described in Note 1 and complying with Division 60 of the *Australian Charities and Not-for-profits Commission Act Regulation 2013*.

Basis for Opinion

We have conducted our audit in accordance with the Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. We are independent of the association in accordance with the ethical requirements of the *Australian Charities and Not-for-profits Commission Act 2012* and the Accounting Professional and Ethical Standards Board's APES 110 *Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling the board members' financial reporting responsibilities under the *Australian Charities and Not-for-profits Commission Act 2012.* As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

Responsibilities of Directors for the Financial Report

The board members of the association are responsible for the preparation of the financial report that gives a true and fair view and have determined that the accounting policies described in Note 2 to the financial report is appropriate to meet the requirements of the *Australian Charities and Not-for-profits Commission Act 2012* and is appropriate to meet the needs of the members. The directors' responsibility also includes such internal control as the board members determine is necessary to enable the preparation of a financial report that is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the directors are responsible for assessing the association's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless the board members either intend to liquidate the association or to cease operations, or have no realistic alternative but to do so.

Auditor's Responsibility for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that
 are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness
 of the company's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the association's ability to continue as a going concern.
